- Payments to be done at SA Embassy's or High Commissions will be done on submission in cash.

## VFS Fees

From 2 June 2014 an amount of R1,350 per person will be payable on all Applications submitted in RSA and all countries with VFS offices, this fee is payable to VFS global. This fee is payable prior to booking the online appointment at VFS (Applications in RSA only, and all VFS offices abroad to be paid on submission at VFS or Embassy / High Commission.) An additional fee of R500.00 is payable per person to the VFS VIP Lounge on submission should you wish to apply in the VIP lounge.
