VFS FEES

From 02 June 2014, an amount of R1 550 per person will be payable on all applications submitted in South Africa and all countries with VFS offices. This fee is payable to VFS global and is payable prior to booking the online appointment at VFS (applications

in South Africa only; all VFS offices abroad to be paid on submission at VFS or Embassy / High Commission). An additional fee of R500 is payable per person to the VFS VIP Lounge prior to booking the online appointment at VFS, should you wish to apply there.

PAYMENT TERMS

- All application fees payable to Immigrants Exclusive are payable in advance.
- Home Affairs fees and VFS fees are payable prior to the online submission on VFS to Immigrants Exclusive.
- VFS VIP / Premium Lounge appointments is payable on date of submission either by credit or debit card, no cash payments.
